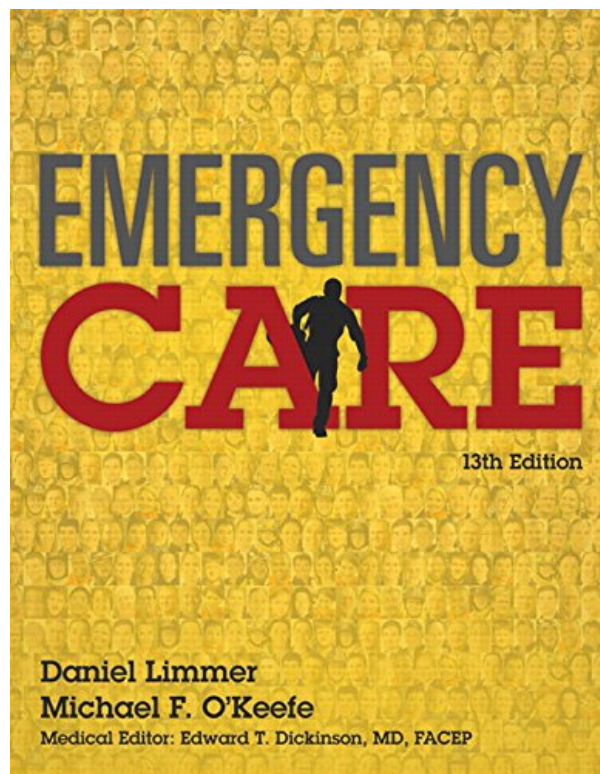
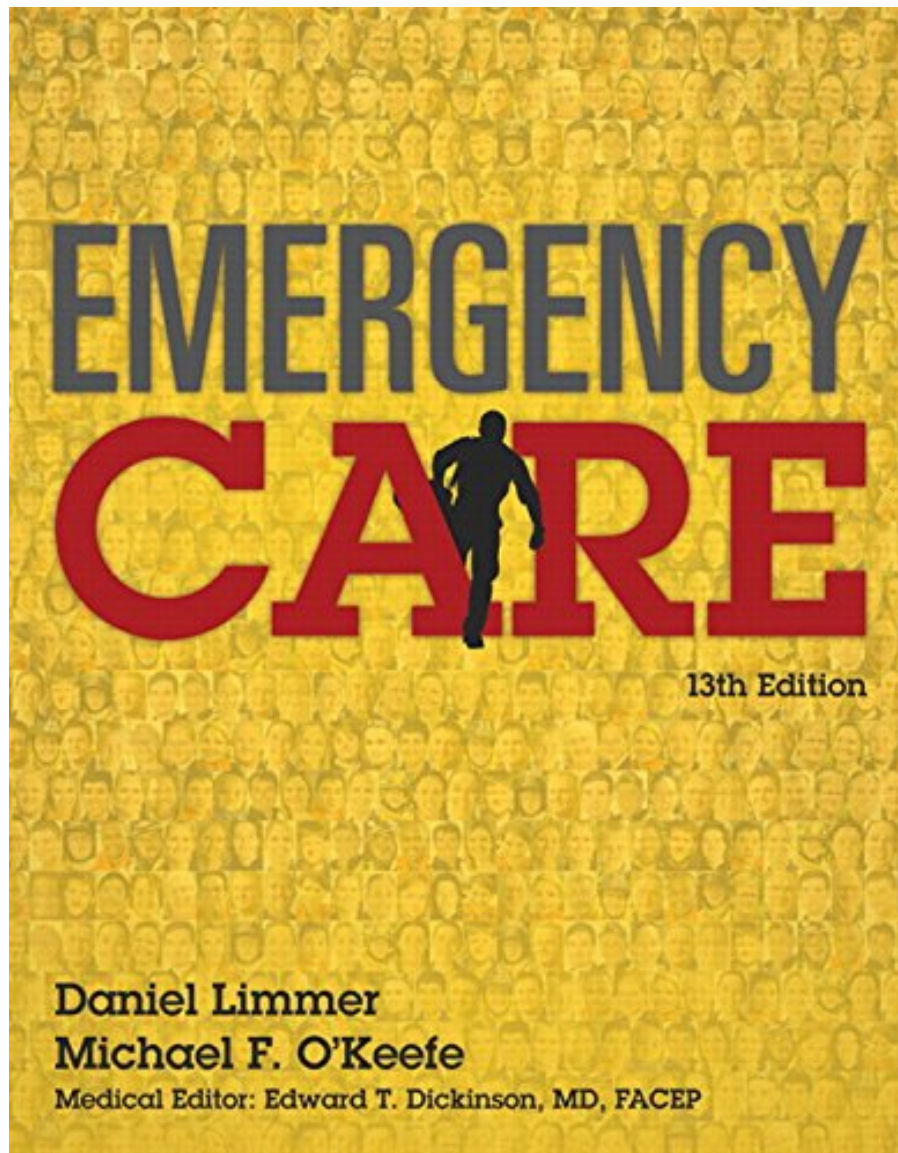

First, let me make it clear, this is a fine textbook for an EMT class, (There are two commonly used EMT textbooks. Based on my experiences with previous editions, I found that i have preferred this one over the other, although many who I respect prefer the other commonly used text,) Some, rightfully, will consider this review unfair.

HOWEVER, i want the publishers to know that I was very disappointed that there is no hardcover edition of this book available, Of all the books I own, and there are many, my EMT text gets the most beaten up. It gets used, reviewed, lugged around from place to play, sometimes taken to work and back, and consulted from time to time when i need to review. I am perfectly willing and prefer to spend the extra five or ten or whatever dollars for a hardcover text that stands up to abuse better.

I hope that when the next edition comes out, they remember that some of us want or need a hardcover editio.

No Access Codes and No Customer Service.

I received this item without the access codes, even though the book is new, was shrink wrapped when I received it, and I paid full price. When going online to the publisher, I discovered that I will have to pay a further \$100 to access the online portion that I already paid for on Amazon. Neither Amazon nor the publisher have a way to call a customer service assistant or to discuss the missing code. I finally found a telephone number, and stayed on hold for over 2 hours without speaking to anyone (at which point my phone died). I ordered the book well ahead of the summer course start date, and now, when I want to make a complaint, Amazon says it's "past the time when you can file a complaint." I have also had to try to post this complaint online three times and it's been rejected each time, despite me following the online guidelines for reviews. You shouldn't have to pay \$200 for a \$100 item.
